- Be a resident of the Clarksville Independent School District
- The application must meet all requirements for promotion from 8th grade to 9th grade (including 90% attendance and minimum GPA 2.5 in core subjects).
- The applicant must have completed all portions of the application for admission.
- The applicant must complete a Summer Bridge Program each summer.
- Clarksville ISD will evaluate student progress while the students is enrolled in P-TECH. If attendance, tardiness, discipline, grades, or parent/guardian cooperation become an issue the administration reserves the right to recommend that the student be dismissed from Clarksville ISD P-TECH.

Clarksville ISD P-TECH, in partnership with Paris Junior College, is a unique program committed to academic success. The independence and self-determination of any student in the Clarksville ISD P-TECH program only exists with the collaboration and alignment of values between parents, staff, community, and the student.

As a CISD parent, I will adhere to the following guidelines to support my child toward success.

- I will ensure my child is in school meeting minimum attendance requirements and absent only for emergencies or illness.
- I will be actively engaged in what my child is learning, encouraging him/her to strive for knowledge including checking my child's grades on a weekly basis.
- I will provide daily time (two to three hours minimum) for my child to do homework without other responsibilities (e.g., babysitting, housework) providing both structure and assistance.
- I will provide my child with a space in the home to study and do daily homework that is free of distraction, as well as support when he/she is struggling.
- I realize it will not be practical for my student to hold an out-of-school job demanding many hours of required work.
- I will be available for meetings and information nights as needed.
- I will make certain my child gets enough sleep each night.
- I will make certain I provide internet access and my child will be required to be on-line at times to complete work and participate in activities.
- I understand as a CISD P-TECH student my child will be exposed to college material. Although Paris Junior College professors are conscious of the age of my child, censoring will be not a part of the student's collegiate curriculum.
- I understand my child will be doing more work than a traditional high school student and may experience extra stress as a result.
- I will keep an active phone number, address, and email with the CISD P-TECH administrators and Clarksville Middle/High School.

Lack of progress may result in my child's removal from the CISD P-TECH program.
