Turner Industries & Clarksville Independent School District

This document confirms our communications and agreements concerning the collaborative partnership that Clarksville Independent School District (Clarksville ISD) and Turner Industries mutually agree to pursue relevant to Pathways in Technology Early College High School (P-TECH). The purpose of the partnership is to support Clarksville ISD P-TECH and enhance students' college and career readiness by providing real world, practical experience and enrichment to students through a variety of activities in which Turner Industries may agree to participate.

Term:

- The term of this agreement shall commence upon signature dates found on the last page of the MOU.
- The MOU will end on June 30, 2025, unless otherwise amended.

Turner Industries

And Clarksville ISD agree to work together to support the following common goals:

- Inform the partner of any scheduling changes that may impact service delivery;
- Develop a method of communicating needs and challenges;
- Collaborate to encourage students to pursue post-secondary education, career and internship opportunities;

Turner Industries will:

- Assign employee(s) to Clarksville ISD P-TECH that promote college awareness and career awareness;
- Recruit and screen employee(s) that mentors students;
- Volunteers/staff shall be willing to complete the volunteer application and background check every calendar year at the campus offices;
- Provide work-based learning experiences (e.g.) field trips, special projects, mentoring), or job shadowing;
- Review curriculum and offer expertise for scope and sequence of college course and work-based learning opportunities;
- Give to a student who receives work-based training or education from the partner under the P-TECH program priority interviewing for any jobs for which the student is qualified that are available on the student's completion of the program.

Clarksville ISD will:

- Establish a college-going culture for all students at Clarksville ISD, which requires engaging students in college coursework, tutoring and advising, and instruction on key "college knowledge" academic and personal behaviors such as time management, collaboration, problem-solving, leadership, study skills, communication, and tenacity.
- Help to define appropriate workplace experiences (e.g. design projects, job shadowing, internships, and clinical practice) that support students gaining key skills needed in the field.
- Allow business and industry leader's access to Clarksville ISD to support program activities.
- Conduct required background checks for business/industry volunteers working with Clarksville ISD students.
- Be responsible for transporting students from Clarksville ISD campus to partnership activities (e.g. work-site visits, job shadowing, internships).
